If you are a food vendor please buy a parking spot.

Please record your vehicle's license plate number, vehicle description and enclose a check for \$60

The parking spaces are only suitable for vehicles of a maximum length of 20'. Oversized vehicles may park at Benbow RV Park. This restriction includes cars towing trailers. We are unable to sell two spaces to one vendor, so if your length exceeds the limit then you must decide which vehicle will remain on-site and which will be parked off site in general parking area.

There is no parking on the lakeside section of the fairway during the festival. This is our fire lane and regulations require us to keep it clear. Cars left parked there will be towed. Cars without parking permit will also be towed.
